Warning signs of a mini-stroke!

A few days ago, I went into the computer village to buy a few items for my office use from a known seller, Semaj. Ordinarily, I had called to inform him that I was coming but as I could not get him on the phone, I decided to visit the village anyways.

On getting to his shop and was asking after him, a young man who resembled him, whom I learnt later is the younger brother, summoned the courage to tell me in a very low tone that Semaj had passed on and I retorted what happened and when? “Semaj died of a stroke, few months ago and has been buried,” he said.

For many Africans, especially the men, they rarely have health checks whereas the women could be checked during children visits to hospitals or antenatal care.

An associate professor of medicine and a consultant neurologist, Dr. [Kolawole Wasiu Wahab](#), in [The burden of strokes in Nigeria](#), published in the National Library of Medicine, noted that the current

prevalence of stroke in Nigeria, for instance, is 1.14 per 1,000 while the 30-day case fatality rate is as high as 40 per cent. The management of the disease is largely conservative while there is little or no funding for high-quality research. Primary prevention, the expert said, is the key to reducing the burden of the disease in a country with such poor resources, which is seen across the continent.

Signs of a mini-stroke:

Experts have said that there are about 7-day signs before a stroke takes effect, including headache, difficulty speaking or understanding, difficulty walking, one-sided arm or leg weakness, dizziness, double vision or other vision problems, confusion, blurred vision, nausea and vomiting.If you have any of these, the best is to see your doctor ASAP.

Cause of a stroke:

Also, as said by experts, estimated 87 percent of strokes are ischemic, which is caused by the blockage in the brain, usually caused by a piece of plaque or a blood clot. If the blockage occurs locally in the brain, the condition is called thrombosis. If the blood clot travels from somewhere else in the body, it is called an embolism.

Can strokes be cured?

The answer is yes. Experts at California-based FlintRehab, affirmed that stroke could be cured, mostly using two stages. “First, doctors administer specific treatment to restore normal blood flow in the brain and stop further damage. Then, the patient participates in rehabilitation to cure the secondary effects that result from the stroke.”

For them, a stroke is considered a “brain attack.” Stroke, thus, occurs when the blood supply in the brain is compromised by either an obstructed artery known medically as ischemic stroke or burst artery also known as hemorrhagic stroke.

Prevention better than cure:

Knowledgeable experts on stroke treatment from the National Health System(NHS) emphasised that the best way to help prevent a stroke is to eat a healthy diet, exercise regularly, and avoid smoking and drinking too much alcohol.

These lifestyle changes, they posited, can reduce your risk of problems like arteries becoming clogged with fatty substances known as atherosclerosis, in other word, high blood pressure.

They recommended that even if one has already had a stroke, making these changes can help reduce risk of having another one in the future.

Equally a recovery plan if one is already diagnosed with a condition known to increase your risk of stroke, by ensuring the condition is well controlled is also important for helping prevent strokes.

Making the lifestyle changes described above could help control these conditions to a large degree, but you may also need to take regular medicine with professional attendance.

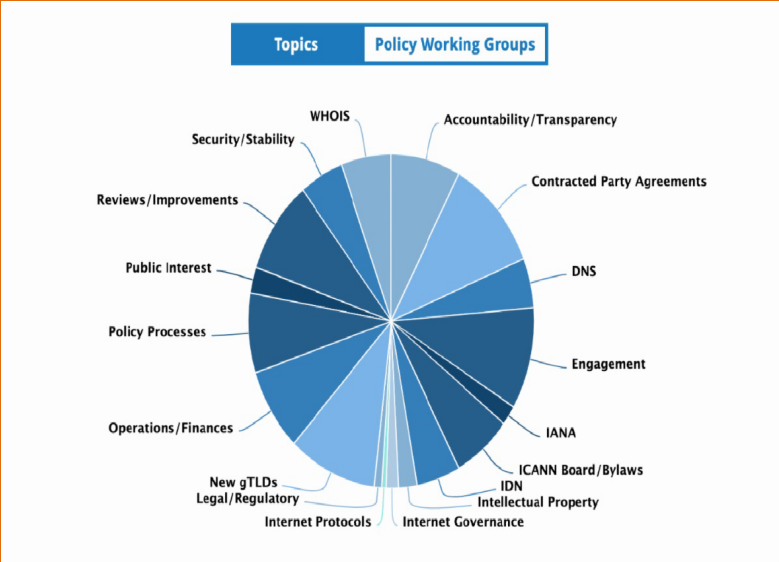

The fifth anniversary edition of Ghana School on Internet Governance (GhanaSIG) fellowship was recently concluded, marking a significant milestone in empowering African youth in e-governance and Internet governance.

Elminiawi invites ALSes to update universal acceptance wiki pages

The chairman of the Africa Regional At-Large Organisation (AFRALO), Hadia Elminiawi has call on members to update their wiki pages, especially on Universal Acceptance of Domain Names (UADN) activities.



UADN experts ensure that all domain names, including new top-level domains (TLDs), Internationalized Domain Names (IDNs), and email addresses are treated equally.

Elminiawi made this call in a letter to the members, saying that the AFRALO members' Universal Acceptance (UA) activities table is now available on AFRALO Universal Acceptance Strategy and Activities wiki page.

ISOC Kenya partners KICTANET for 2024 national IGF

The Kenya ICT Action Network (KICTANET) played host to the country Internet Governance Forum (IGF) on August 1, 2024 as coordinated by the Multistakeholders Advisory Group (MAG), with the Internet Society (ISOC) of Kenya.

Joel Okomoli of the Internet Society Kenya Chapter, reported that they were key participants with many of their members in attendance, including the pre-events namely the Youth IGF and session calls.



He also said that the East African IGF was scheduled for Kampala on the 11th to 12th September 2024. The link for details is shared [here](#).

This is coming as ISOC Kenya revealed it has submitted two proposals for setting up and managing an Internet exchange Point and data centre in the Western town of Bungoma that lies on the digital highway to Uganda and beyond.

The first proposal, he said, was in response to the ICANN Grant Call which covers the cost of half of the equipment required including servers and power unit, staff salaries for one year and connection fees.

Okomoli equally said, the second proposal was submitted in response to the Resiliency Grant Call by ISOC Foundation. It covers the remaining half of the equipment, staff salaries for another year as well as Internet Connection.

As said by him, both projects will run concurrently although the resiliency grant if awarded commences earlier in September 2024.

The project, therefore, aims to host the third instance of ICANN Managed Root Server (IMRS) in Kenya and strategically located in the Western Region. This, industry observer said, will be a great opportunity to tap into the Internet traffic from Uganda, Rwanda among other Central African countries, whilst reducing latency and train a specialized skill-set to help in growing the Internet in the region.

EGIGFA, GDNR, AAU collaborate to host Ghana UAD workshop

The E-Governance and Internet Governance Foundation for Africa (EGIGFA) in collaboration with the Ghana Domain Name Registry (GDNR), and Association of African Universities (AAU) have hosted a Universal Acceptance (UA) Day technical workshop in Accra.

Dr. Oloyede Abdulkarim, a UA Ambassador from Nigeria was the lead trainer, which enhanced the understanding and technical skills of the participants on Universal Acceptance for global internet inclusivity.

The workshop included sessions on the importance of UA, technical configurations to support non-Latin scripts and strategies to overcome implementation challenges. Participants engaged in hands-on and discussions, gaining insights into best practices and successful case studies.

Key outcomes included increased awareness, improved technical capacity, and opportunities for collaboration among stakeholders. The workshop concluded with recommendations for continued education and further workshops to advance UA adoption in Ghana and Africa.

Ms. Nodumo Dhlamini, Director of ICT Services, Communications & Knowledge Management at AAU delivered the welcome address. Mr. Raymond Mamattah, Founder and President of EGIGFA, and Nana Kofi Asafu-Aidoo, Executive Director of GDNR gave the opening remarks. Mr. Benedict Obirim Sagoe of GDNR gave the closing remarks.

The training was attended by over 70 Systems administrators, DNS administrators, Email administrators, developers, and webmasters from academic institutions, financial institutions, government agencies, civil societies, and the technical community.
