The applicant entered No as reply to this point on the application form as ISOC Korea works towards the interests of Korean residents primarily, but does not restrict its membership geographically in theory. IN practice, membership is exclusively Korean for now.

As per application form: ISOC Republic of Korea chapter (from now on ISOC Korea Chapter) was officially

recognized in November, 2014. There are 48 members registered as of 27th of February, 2015. ISOC Korea chapter facilitates Internet governance dialogues in Korea inviting all stakeholders, civil society, academia, private sector and government. ISOC Korea chapter aims to serve individuals who live and/or work in Republic of Korea. Chapter also places high emphasis on enhancing collaboration between members of ISOC Korea chapter members and ISOC community.

Members of the community residing in Republic of Korea are eligible to join the chapter but members do not have to be residents of Republic of Korea.”

As per email exchange with applicant: “Korean residency is not compulsory for a membership application. We still try to have a better idea of balancing local interests and global interests as a chapter based in Korea”

“48 members as of 27th of February, 2015. Those 48 members are global members of Internet Society as well as members of ISOC Republic of Korea. Also, There are more than 70 local members who haven’t registered as global member of ISOC yet.”

The proportion of total membership from governmental bodies is about 15% to 20%.”

ISOC Korea does not however receive funding from the governmental bodies, this dates back to the 27th February 2015.

As per email exchange with applicant: “Even though we have organizational member for our chapter, it was not officially processed yet. Therefore, people from KISA (one of serious stakeholders of ccNSO in ICANN structure) joined ISOC KR as individual members. As you know KISA is semi-governmental body. We also have people from other governmental research agency like ETRI. So, those individual members from governmental bodies have the equal rights like other individual members.”

As per email exchange with applicant: Yes, of course. We once widely open our meeting to everyone but we all realized there was difficulty with communicating when people cannot speak any Korean. On the other hand, AIS in Seoul on May 7th invited two people outside of Korea. One is Olaf Kolkman, CTO of ISOC and Naveed Haq from ISOC's AP regional office. So, we like to invite as many experts as possible from outside of Korea down the road. “

As per email exchange with the applicant: “This is the one of key challenges when we now prepare for the upcoming event, AIS, here since we do not have any money with our account. What we did here is we tried to make arrangements with the related organizations, OSIA, TTA, IETF Mirror Forum, and KISA who are willing to contribute a certain expenses of this event. We also plan to apply for 3000 USD from ISOC APAC office. The whole expense of this upcoming meeting was estimated at around 10,000 USD. Around 7,000 USD is going to be sponsored by our associated institutions who are yet a formal organizational member of ISOC Korea Chapter. “

As per email exchange with applicant:

Staff: I would just like to add an extra question regarding the funding of ISOC Korea. You mentioned the funding of the upcoming events, and negotiating with associating partners. What will happen after this? Will these partners become member organizations of ISOC Korea? If so, does this imply that they will be paying members, or approached for occasional funding? Will this give them greater influence in the decision making process?

Applicant: That is the idea we have now. Other than those governmental agencies who can process their membership fee like KISA, we also have independent associations like OSIA (FYI OSIA is already a member of APRALO) whose connection to ISOC Korea will be more like partnering association. In line with this arrangement, we seek interests from Korea IT industry such as SK Telecom and Naver. This time SK telecom plans to contribute to this event as well. After this event, we plan to have hopefully around ten organizational members including industry who can pay their membership dues down the road. That is our long-term plan. At this stage, many people and institutions do not see the value of ISOC and ISOC Korea chapter here in Korea. It is the reality. That was one of motivations we try to host AIS where people can see the value of ISOC/ISOC Korea chapter.

Staff: If this is not the case, are you considering membership fees for individuals, or do you envisage continuing with volunteer work with occasional funding through sponsorship?

Applicant It would be very unfair to depend on volunteer work on the long term basis. I do not think this is the sustainable model at all. I have been there many times and I hope this is another volunteer work in a very limited time.

He is currently on the board of .ASIA 2nd, Jaechon Park has been attending ICANN and IGF meeting quite regularly since 2007. 3rd, Kyujin Wee has not been attending the typical IG meetings yet but he has been very engaged with ITU process for more than 20 years as a part of his career. He was one of few people who believed Korea should have ISOC chapter.”
