The intention of iPNGC was to become a national multi-stakeholder forum for internet users, service providers and stakeholders to discuss debate and engage in issues and opportunities that shall emerge as a result of internet technology deployment in the country; and openly share views and ideas for common benefit for everyone. Just recently, on the 20th of October 2016, iPNGC was registered as a civil society in Papua New Guinea under Associations Incorporation Act. iPNGC is already attracting interests from local, regional and international organizations for partnerships and collaborative works.

ARTICLES OF ASSOCIATION

Article I

Preamble

This By-Law identifies this society; forms the basis of its functional structure, and states the core of its operational objectives. It has nine (9) articles, including Preamble and each shall be read in Parts and Clauses.

Article II

Name and Organization

A) The name of this society is Internet PNG Clique, and official acronym is iPNGC with a small 'i'. The official logo of iPNGC shall be decided by the board once the society is registered.

B) Internet PNG Clique (iPNGC) is designated as an unincorporated not for profit organization created under the laws of the Independent State of Papua New Guinea.

Article III

Intent and Purpose

A) The iPNGC consists of over one hundred members to date with growing membership, plus Special Interest Groups (SIGs); with mutual consent for common not for profit purposes to foster sustainable Information and Communication Technology (ICT) growth.

i) The purpose of iPNGC is to leverage the growth and development of ICT particularly internet in Papua New Guinea (PNG), through education and awareness on internet technology standards, ICT policy developments and related Internet Governance (IG) issues in the country and the region.

ii) The intention of iPNGC is to become a national multi-stakeholder forum for internet users, service providers and stakeholders to discuss debate and engage in issues and opportunities that shall emerge as a result of internet technology deployment in the country; and openly share views and ideas for common benefit for everyone.

iii) The iPNGC shall commit to helping improve lives through the use of ICTs and empowering society through communication and access to information. Recognising the Internet as a tool for societal growth

iv) To create awareness and facilitation of ICT professionals and organizations in the country to participate and engage in regional and global bodies and organizations associated and tasked with internet engineering, coordination, development and management.

v) The aim of iPNGC is to mould informed and responsible internet users, service providers and stakeholders.

B) The engagement of members, stakeholders and the internet user community for this purpose shall mainly be online via mailing list, social media, web blogs, newsfeeds and occasional print media. The posts, messages, and information shared shall be moderated by a board member tasked as moderator; to ensure they are on-purpose and ethical.

C) Internet PNG Clique may elect to involve in local, regional and international ICT events; pertaining to and guided by the Volunteer Service or Charity Organization Act under the PNG national constitution and agreed by iPNGC board.

To these ends, iPNGC may do and engage in any and all lawful activities that may be incidental or reasonably necessary to any of these purposes, and it shall have and may exercise all other powers and authority now or hereafter conferred upon unincorporated not for profit corporations under relevant laws of the Independent State of Papua New Guinea.

Article IV

Office and Duration

A) The office of iPNGC shall temporary be located at PNG ADOC Centre, inside Matheson Library at PNG University of Technology, Lae, Papua New Guinea. The permeant location and address shall be determined by the board at such a time the institutional arrangements are in order.

B) The duration of iPNGC shall be perpetual. The death, removal, or resignation of any board member or executive of iPNGC shall not result in the dissolution of iPNGC, but the roles and functions shall be delegated to board members appropriately.

Article V

Structure and Membership

The iPNGC consists of individuals and groups dedicated to and have interests in the development of internet in the country.

A) Membership shall be open to anyone wishing to learn and share about internet technology and subsequent issues and opportunities in the country.

i) The iPNGC is a purely voluntary organization, and no membership fee or annual dues shall be required for membership.

ii) Membership shall be maintained by mailing list until and when appropriate register is in place. New members are invited, added or requested via mailing list.

iii) Individuals and organizations will not be considered members of iPNGC unless and until they join the mailing list or are acknowledged in writing by the society executives.

B) Organizational structure shall be flat.

i) Membership categories shall be decided and introduced by the board should there be a need for effective communication, membership management or similar.

ii) The iPNGC promotes equal participation, and hereby does not discriminate on the basis of race, colour, sex, age, religious affiliation, handicap, national origin, or other personal factor.

Article VI

Society Leadership

A) The iPNGC shall be governed by at least five (5) officers as board members to be determined by the society members through volunteering and endorsements by the current board annually.

i) Composition of board shall include but not limited to members from various organizations and or individuals that have interest in internet technology in PNG and from among iPNGC members.

ii) Geographical locations of membership composition shall be considered essential but not mandatory.

iii) The removal, resignation or similar for board members shall be voluntary and no authority therein for quorum to enforce expulsion and appointment.

iv) In the event of death or voluntary step-down, the vacant position/roles shall be shared among existing board until new election.

v) One person will be designated as board chair, with two vice chairs and two board members with specific roles.

vi) The name and total number of officer positions will be determined as the group requires, changeable as circumstances necessitate.

vii) Two-thirds of the current board members constitutes a quorum of iPNGC.

viii) The board shall meet and communicate online. And convene at suitable time and location when opportunity arises

B) For specific events including board elections; the current board shall decide before information circulation to membership for feedback.

Article VII

Accounting & Records

A) The fiscal year of iPNGC shall be January 1 through December 31 of each year.

B) All minute books, correspondence, and other records of iPNGC shall be preserved by the Officers. Records that have ceased to be of use for the conduct of the affairs of iPNGC may be turned over for preservation to a depository designated by it, or discarded.

Article VIII

Dissolution

A) In the event of the dissolution of iPNGC; all its affiliations, agreements, and other valid responsibilities entrusted by the government, local, regional or international partner organizations shall cease immediately.

B) Due tasks shall be transferred to similar organization or organizations operated exclusively for charitable, educational, and/or scientific purposes as iPNGC may determine, provided such organization or organizations qualify under Volunteer Service or Charity Organization Act of PNG.

Article IX

About The By-Laws

A) The By-Laws shall come into effect upon official notice of Registration of Association granted by Investment Promotion Authority (IPA) of Papua New Guinea to iPNGC.

B) They shall remain valid in concurrent with the existence of iPNGC; until and when there shall be need for review, due to change in circumstances.

C) Modifications, additions and amendments to the articles shall be endorsed and made by the board quorum.
