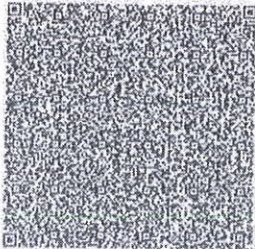

Whereas the Settlor of the Trust already established a Trust on 02.07.2009 for advancement of the society by way of providing internet access to those who cannot afford Computers and Internet Connection at home or at work in India and also to promote, support and safeguard the interest of retail internet service providers including internet cafe/cybercafe, who provide computers and internet connection to the public in the name of Cybercafe Association CCAOI

Whereas the Settlor herewith modify the above deed declaration by changing, modifying and adding the following clauses:

1. Clause 6 b. of the Deed of Declaration of the Trust, hereinafter changed and modified and remain as under:

The Settlor Mr. Naresh Ajwani, son of Shri. A.M. Ajwani aged 54 years, resident of C2B-111/112 B Janakpuri, New Delhi, appoints Ms. Amrita Choudhury, daughter of Dr. Bhaskar Choudhury aged 43, resident of Flat 1301, Tower 8, Lotus Panache, Sector 110, Noida as the Permanent Trustee and Settlor of the Trust. During the tenure of the Permanent Trustee she has the right to appoint any other person as the Permanent Trustee of the Trust. If no permanent Trustee has been appointed by the existing permanent Trustee during her tenure, the Board of Trustees shall appoint by majority one of its Trustee as Permanent Trustee of the Trust or may also decide not to appoint any person or Trustee as the Permanent Trustee of the Trust. If no Permanent Trustee is appointed by the Board of Trustee for a period of one year, from the date of vacancy of Permanent Trustee, it shall deemed be considered that the position of Permanent Trustee has been abolished from the Trust and thereafter the Trust shall be managed by the Board of Trustees and the decisions of the majority of the Trust shall be final and binding on the Trust including the appointment of Trustees, management, control, amendment of the Trust and dissolution of the Trust.

2. Clause 4 of the deed of Objects of the Trust, hereinafter modified and remain as under:

The main objects of the Trust are to develop and advance the society by providing internet access to the public in general, including:

- a) To spread the usage of Internet among the people.
- b) To provide computers and internet connectivity to those who cannot afford computers and internet connection at home or at work.
- c) Promote, support and safeguard the interest of retail internet service providers, including internet cafe/ cybercafe, who provide computers and internet connection to the public.
- d) Promote, support and safeguard the interest of internet users and non users.
- e) To provide internet connectivity to the public at reasonable cost or only for the cost of usage.

f) To advance the people of India by providing them internet at reasonable cost which will open doors for them for vast opportunity.

g) Build capacity and conduct Research activity to promote the use of Internet.

3. New Clause as Under;

a) Hereafter, the address for all Bank and Income Tax related correspondence of the Trust, will be the address of the Permanent Trustee Amrita Choudhury, Flat 1301, Tower 8, Lotus Panache, Sector 110, Noida

The Supplementary deed shall always accompany the original deed of declaration of the Trust.
