Bylaws of the Internet Society Republic of Korea Chapter
(October 14 2014)

Article I. - Name

1. This organization shall be called Internet Society Republic of Korea Chapter

Article II. - Purpose

1.Internet Society Republic of Korea facilitates more engagements with Internet governance dialogues in coordination with ISOC, IETF, IGF, ICANN, WEF, and other institutions in Korea.

2.Internet Society Republic of Korea enhances collaboration with ISOC community as a member of the global Internet community through a local presence, focusing on local issues and developments, and use of local languages.

3.Internet Society Republic of Korea will serve persons who live or work in

Republic of Korea.

4.Internet Society Republic of Korea is chartered by the Internet
Society. These bylaws neither supersede nor abrogate any of the
Bylaws of the Internet Society that regulate chapter affairs.

Article III. – Membership

- 1.Internet Society Republic of Korea shall have two classes of members: Organizational Members and Individual Members.
 2.All members of Internet Society Republic of Korea chapter shall also be members of the Internet Society. Membership is not necessary, however, for participation in activities of the society or its chapters.
- 3.All individuals and organizations falling within the defined scope of ISOC Korea shall be eligible for membership without discrimination.
- 4. Membership in Internet Society Republic of Korea shall be open to all Internet Society members in the locality served by the Internet Society Republic of Korea Chapter.

Article IV. – Officers

- 1. The officers of Internet Society Republic of Korea shall be composed of Chair, Two Vice Chairs, Public Relations Officer, Treasurer, and Secretary.
- 2. Each officer cannot take more than two consecutive terms.
- 3. The officers shall be elected at the General Assembly meeting.
- 4. The term of the officers shall be two years.
- 5.Those who are elected shall take office immediately upon election and serve until their successor is elected.

Article V. - Duties of Officers

- 1. The chair is the principal officer and is responsible for leading Internet Society Republic of Korea Chapter and managing its activities in harmony with the policies and procedures of the Internet Society. The Chair shall preside at all meetings of Internet Society Republic of Korea and of its Executive Council. The Chair interacts with ISOC headquarters including some reporting to Internet Society Headquarters.
- 2.The Vice Chair shall preside at meetings in the absence of the Chair. The Vice Chairs promote Internet Society Republic of Korea at global stages.
- 3. The Secretary shall keep the minutes of all Chapter and Executive Council meetings.

- 4. Public Relations Officer raises strong profiles in Republic of Korea.
- 5.Secretary and Public Relations Officer prepare for the Annual Internet Society Republic of Korea Report for presentation at the Annual General Assembly.
- 6.Secretary and Treasurer prepare for the Internet Society

 Republic of Korea's Annual Financial Report for presentation to

 the Chapter at the Annual General Assembly.

Article VI. - Executive Council

- 1. The Executive Council shall consist of the present Chapter officers and the immediate Past Chair and senior industry representative, if applies.
- 2. The term of the members of the Council shall coincide with the terms of the officers.

Article VII. - Standing Committees

1. The Standing Committees of the Chapter shall be created if the necessity arises and the chair of the standing committee will be a member of executive council.

Article VIII. - Temporary Committees

1. With the advice of Internet Society Republic of Korea Executive

Council, the Chair may appoint such temporary committees as

appropriate.

Article IX. - Meetings

- 1.Internet Society Republic of Korea shall hold meetings only in places that are open and accessible to all members of its members.
- 2. The Annual General Assembly shall be held either in November or in December every year. At this meeting, the Chair shall present a report to members.
- 3. The election of officers shall be held during the Annual General Assembly every two years.
- 4. Notices of the place and time of all meetings shall be distributed to all members at least two weeks prior to any meeting by Internet mail or by oral, telegraphic, or other written notice, duly served on or mailed.

Article X. - Dues

- 1. The individual membership of Internet Society Republic of Korea dues will be exempted.
- 2. The organizational membership of Internet Society Republic of Korea dues will be collected. The specific amount of membership

dues would be decided by executive council.

Article XI. - Amendment and Voting Procedures

1.All proposed changes to these Chapter Bylaws shall have been

approved by the Internet Society before being presented to the

Chapter membership for a vote.

2.No official business of the Chapter shall be conducted unless a

quorum of the Chapter is present.

3.A quorum of the Chapter shall be defined as 30 percent of the

voting membership of the Chapter or at least 40 members,

whichever is greater.

Article XII. – Dissolution of the Chapter

1.Dissolution of Internet Society Republic of Korea by consent of

the members shall consist of unanimous agreement of all its

officers at the publicized meeting.

2.Should Internet Society Republic of Korea be dissolved, its

assets shall be transferred to Open Standards and Internet

Association (OSIA).
