## **GOVERNMENT ORDER**

### **APPOINTMENT OF A NEW MANAGER FOR THE ccTLD.nu**

PURSUANT to the Communications Amendment Act 2000 no. 251.

WHEREAS, the management of the ccTLD.nu must comply with the Communications Amendment Act 2000 no 251.

WHEREAS, the Communications Amendment Act 2000 no 251 stipulates that the ccTLD.nu is a national resource for which the prime authority is the Government of Niue.

WHEREAS, the Communications Amendment Act 2000 no 251 stipulates that only entities approved and appointed by the Government of Niue may manage the ccTLD.nu.

WHEREAS, the enactment of the Communications Amendment Act 2000 no. 251 in 2000 effectively nullified the former MOU between the Government of Niue and the currently designated manager, the IUSN Foundation, which was entered into by the parties in 1999.

WHEREAS, the currently designated manager of the ccTLD.nu, the IUSN Foundation, has since 2000 acted as the manager of the ccTLD.nu without any approval of the Government of Niue and in breach of Niue law.

WHEREAS, the currently designated manager of the ccTLD.nu, the IUSN Foundation, has since 2000 managed the ccTLD.nu in a manner thoroughly harmful to all interests of the local internet community in Niue.

WHEREAS, the Niue Information Technology Committee (NITC) has since 2000 been consistently denied oversight of the ccTLD.nu, which is necessary to ensure domain safety and national security.


WHEREAS, Niue National NU Domain Company Ltd was incorporated in 2021 solely to act as the lawful and duly approved and appointed manager of the ccTLD.nu.

WHEREAS, Niue National NU Domain Company Ltd has the unequivocal support of the local internet community in Niue to handle the management of the ccTLD.nu.

NOW, THEREFORE, by virtue of the authority vested in the Government of Niue and the Crown Law Office by the Constitution and the laws of Niue, it is ordered that Niue National NU Domain Company Ltd is hereby appointed manager for Niue's national Top-Level Domain, the ccTLD.nu, in accordance with section 30 B(b) and section 30D of the Communications Amendment Act 2000 no. 251.
