

ccTLD Contributions as of Fiscal Year 2023

The following table summarizes the contributions paid to ICANN from ccTLD registries for the past five fiscal years, by contribution year, beginning 1 July and ending 30 June the following calendar year. All contributions are reported in United States Dollars (USD).

The information included in the table below is based upon the ICANN fiscal year for which the contribution was made (as indicated on the invoices), irrespective of the effective date on which the invoice was issued. As an example, an invoice issued on 31 July 2023, for a contribution pertaining to ICANN's fiscal year 2023 (which closes on 30 June 2023), would be reported in the column ICANN FY23, even though the invoice was issued at a date included in ICANN's fiscal year 2024.
